It is also strongly recommended that cats and kittens be tested for FeLV before entry. All claws of entries must be clipped. **Scoring:** All entries in Championship (except Novice), Premiership (except Novice), registered kittens, recorded HHP and registered cats competing as HHP with a HHP color class prefix will be scored for CFA awards.
