ENTRY INFORMATION: CFA Show Rules will govern this show. A copy of the show rules can be obtained by sending \$7.00 to CFA, Inc., 260 East Main Street, Alliance, OH 44601. Entries for Championship, Premiership, AOV and Provisional classes must have registration numbers on the entry blank to be printed in the catalog. No kittens under the age of 4 months or cats not entered in the catalog are allowed in the show hall. Entry Clerk will phone collect to clarify entries where necessary. Benching requests will be honored whenever possible. Only one benching request or agent per exhibitor. No Negative Benching Requests, Please. Show rules will be strictly enforced.

HEALTH: This is a non-vetted show. Exhibitors are urged to have all cats and kittens inoculated against Calici virus, Feline Enteritis, Rhinotracheitis and tested for FeLV. All cats must be free from infections, ear mites, fleas and contagious diseases. Claws must be clipped. All kittens must be four months of age *on or before* the first day of the show.

CHECK-IN: Check in is from 6:30a.m. to 7:30a.m. Anyone not checked in by 7:30a.m. will be marked absent. The show starts promptly at 8:00am. Show hours are 8:00a.m. – 6:30p.m. No cage/show tent may be dismantled without the Show Manager's approval until all finals have been completed.

THE SHOW HALL: Yolo County Fairgrounds – Waite Hall, 1250 E. Gum Avenue, Woodland, CA 95776. The show hall is air conditioned and heated. Neither Poppy State Cat Club nor the Yolo County Fairgrounds will be responsible for damage, loss, personal injury, or loss of personal property. No Smoking in the show hall. Absolutely no liquor allowed on premises or in the show hall. Show hall and facilities are handicap accessible.

AIRPORTS: Sacramento International Airport is 12 miles away from the venue (17 minute drive).

DRIVING INSTRUCTIONS TO SHOW HALL:

From Sacramento International Airport: Take Interstate 5 North towards Redding, exit East Main Street and turn left (west), turn left on Matmor Road, turn right onto East Gum Avenue. Fairgrounds entrance will be on the left at 1250 E. Gum Avenue. Once on grounds, head to Waite Hall. Parking is free.

From Highway 113 North: Exit East Gibson Road and turn left, turn right on East Street, turn right on East Gum Avenue. Fairgrounds entrance will be on the right at 1250 E. Gum Avenue. Once on grounds, head to Waite Hall. Parking is free.

HOTEL: La Quinta Inn & Suites in Davis, CA or Best Western Shadow Inn – Woodland, CA

SPACES: EXHIBITORS ARE RESPONSIBLE FOR THEIR OWN BENCHING ENCLOSURES. Spaces are 22" wide and 24" deep. One cat or two kittens may be benched per cage. Exhibitors

with cages larger than this will need to purchase a double space.

LITTER AND FOOD: Cat litter will be provided. You are to provide your own litter pan, food and water bowls and food and water for your cat(s).

DURING THE SHOW: This will be a fast-paced show to get through 8 rings in one day. *CFA show rule Article XI, 11.07 states, "Only one call to the judging ring is required."* We will accommodate 2 calls to the judging ring. After the second call, if your cat is not caged in the ring in a timely manner you will be marked as absent.

ENTRIES AND FEES: MAKE CHECKS PAYABLE TO POPPY STATE CAT CLUB. No refund for failure to bench. No postdated checks. There is a \$50.00 charge plus bank fees for returned checks. All entries must be paid by December 16, 2025. Due to this new show format, we cannot take entry payments at the door the day of the show. Checks can be mailed to:
