**ENTRY & PAYMENT INFO:** Entries are accepted now. Entry fees include CFA & regional surcharges. Please email entry clerk to confirm online entries. Per show rule 6.21 each entry must be accompanied by the stipulated entry fee. All online/fax entries must be paid in full within 10 days of receipt or prior to the start of the show, whichever is first. Please make checks payable to Star City Cat Fanciers; PAYPAL IS NOT AVAILABLE. No refunds after the entry clerk has confirmed your entry or for failure to bench. No substitutions after the closing date. Check your confirmation for accuracy and contact the entry clerk with any corrections BEFORE THE CLOSING DATE.

**SHOW HOTEL:** Holiday Inn - Valley View 3315 Ordway Dr. Roanoke, VA, [540-362-4500](tel:540-362-4500). Call the hotel and ask for the "cat show rate". Room Rates - \$129 (NO pet fee) no pet fee but exhibitor will be responsible for any room damage. Sorry, the club cannot provide transportation

**CHECK IN:** Saturday from 7:30 - 8:30 am. Cats not checked in by 9:00 am will be marked absent and the exhibitor must check-in with the clerk in each ring. Payments at check in must be in cash only.  
**JUDGING HOURS:** 9:00 am on Saturday and Sunday. ADVERTISED SHOW HOURS: 9:30 am - 4 pm (or end of judging) Saturday and 9 am - 4 pm (or end of judging) Sunday.

**HOUSEHOLD PETS:** All entries must be at least 4 months old; all entries 8 months or older must be neutered or spayed. Entries may not be declawed.

**BENCHING:** Single cages are approximately 22"x22"x22" and is included with your entry. Litter will be furnished. Bring your own litter pans, dishes and cat food. Novice exhibitors should bring cage curtains and grooming supplies. Please bring your cat in a suitable carrier.

**HEALTH:** It is strongly advised that all cats or kittens entered or present in the show hall be inoculated before entry by a licensed veterinarian against feline panleukop (formerly known as feline distemper or feline infectious enteritis), feline rhinotracheitis, calicivirus and rabies. It is also strongly recommended that cats and kittens be tested and found negative for FeLV before entry. All claws of all entries must be clipped prior to benching. Declawed cats are not eligible for competition.

**SCORING:** All entries in Championship (except Novice), Premiership (except Novice) and registered Kittens will be scored for CFA awards. Owners of cats/kittens w registration numbers can contact the entry clerk for a Temporary Registration Number. Rosettes will be awarded and permanent flats will be used in accordance with CFA rules. This is a CFA licensed show and all show rules will be strictly enforced. For a copy of these rules, contact CFA, 260 E. Main St. Alliance, OH 44601.

**SHOW RULES:** The show will be conducted in accordance with current CFA show rules. Show rules are available for \$5 plus \$2 postage from CFA, 260 East Main St. Alliance, OH 44601 or online. **LIABILITY:** The Cat Fanciers' Association or the Holiday Inn will not be responsible for damage, loss, or personal injury during this event.
